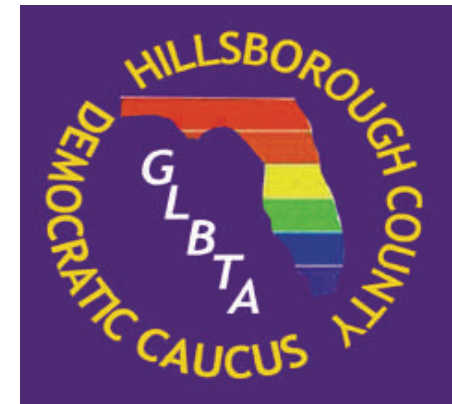

M E M B E R S H I P

Eligibility for Membership

Democrats registered to vote in Hillsborough county interested in the objectives of this club/caucus shall be eligible for membership. No other residency restriction may be placed upon membership or the privileges of membership in this club/caucus. In accordance with Article VI of the Florida Democratic Party Bylaws, with the exception of the organizational meeting of this club/caucus, those members permitted to vote in any club election for officers or board members must have been a member of the club/caucus at least forty-five (45) days prior to the date of such election. Officers and directors shall be required to execute the Loyalty Oath in the form included in the Bylaws of the Florida Democratic Party.

Friends of the Organization

Mindful of the need to reach out and the benefits of a policy of inclusion, a person who:

- (a) is not a Florida resident, or
- (b) is not eligible to register to vote in Florida, **or**
- (c) others who subscribe to the purpose and mission of the organization, shall be a "friend", upon payment of dues specified by the Board. "Friends" may speak at meetings and assist on committees, but may not vote.
